EF DOLLARS SUPPORT IMPORTANT PROJECTS IN THE SAN FRANCISCO BAY AREA

The AAUW Educational Foundation (EF) has a long and distinguished history of advancing educational and professional opportunities for women in the United States and around the globe. EF provided more than 250 fellowships, grants, and special awards to outstanding women in the 2007-08 academic year. One such type of grant is the Community Action Grant that provides seed money for innovative programs or non-degree research projects that promote education and equity for women and girls. Four such awards were made in the San Francisco Bay Area in 2007-08.

The First Step: Beginning English Skills for Success - This program provides weekly educational, vocational, and language-acquisition training and technology-based classes to 25 low-income, ethnic, immigrant, refugee, and limited-English-speaking women who are entering a learning environment for the first time. The program will improve the lives of these women while increasing their English literacy level and providing access to bilingual job-training programs and information technology. The program is managed by Pat Davis at the Learning and Loving Education Center in Morgan Hill.



PUBLIC POLICY UPDATES

AAUW-CA has an able lobbyist in Sacramento. Charlotte Newhart is experienced, well connected, friendly and tough. However, she is up to the job of her life as the governor has announced that California's tough financial position has made him think seriously about reducing state monies for education, health programs, programs for the poor, and other programs AAUW considers vital for our state. At a November meeting, Newhart admitted that the coming year would be tough to advocate for but now the situation seems desperate. In the coming months there will be a call to arms from every major lobby in California arguing for the state to keep its promises to their clients.

The new year also brings notice that the people behind propositions 84 and 73 in past elections have not given up their fight. In a new direction, they will again bring up the fight for parental notification for females under the age of eighteen who seek abortions. Those propositions were defeated before but in a new atmosphere of conservative legal direction, the backers think they have a new argument to bring to bear.

A federal appeals court has ruled that U.S. Secretary of Education Margaret **Spellings** is violating the spending clause of the U.S. Constitution by requiring states and school districts to spend their own funds to comply with the No Child Left Behind Act. The lawsuit was brought by the National Education Association, nine school districts and nine NEA state affiliates to oppose costly federal regulations that were not supported by federal funds. If the ruling stands, it will mean that the U.S. Department of Education cannot require states and local school districts to comply with the requirements of NCLB that are not paid for by the federal government. President Bush demanded that Congress reauthorize the act, and threatened that if Congress passes a bill that weakens the accountability system in the NCLB Act, he would oppose it and veto it. Although the law expired at the end of September 2007, an automatic one year extension built into the law has kept it operating. In addition to other recommendations for reforming the NCLB Act, AAUW supports the inclusion of science as a required area of assessment under the NCLB Act's measurement of adequate yearly progress.

Title IX's impact on women's athletic participation is one of the country's greatest success stories. AAUW strongly supports the High School Sports Information Collection Act (S. 518), which would require high schools to report basic information on the number of female and male students in their athletic programs and the expenditures made for their sports teams. Sadly, this bill only has five co-sponsors. Please urge your senators to co-sponsor the High School Sports Information Collection Act.
