GLOBAL INFLUENCE OF EF DOLLARS

In 2008-2009, AAUW Educational Foundation (EF) awarded 75 International Fellowships totaling \$1,486,000. Applications were received from 122 countries.

International Fellowships are awarded for full-time study or research to women who are not U.S. citizens or permanent residents and support graduate or postgraduate studies at accredited institutions. Recipients are selected for academic achievement and demonstrated commitment to women and girls. The overwhelming majority return to their home countries to become leaders in their fields as heads of state, university professors, community activists, world-renowned artists, and scientists. Four International Fellows are studying in California this year:

Thang Dao is from Vietnam and has a Ph.D. in Humanities from USC. Her project, "The Invisible Marks of Exile: Vietnamese Writers Overseas," examines works by female writers of Vietnamese origin from all over the world to highlight a forgotten intersection of gender and displacement and to demonstrate the woman as both a victim and an agent in a changing global political/economic system.

Aoife O'Donovan is from Ireland and has a Ph.D. in Psychology from UCSF. Her project, "Social Support and Biological Risk Factors for Disease in Caregiving Women," examines social resources available to women caring for a relative with dementia and elucidates the biological pathways by which aspects of social relationships influence health outcomes in women.

Andrea Thring is from Canada and has an M.A. in Counseling Psychology from the California Institute of Integral Studies. Her project, "Counseling and Educating Women and Young Girls Dealing with a Range of Different Issues," examines using drama therapy as a means of healing and bringing together communities with a primary focus on the rights of women.

Patience Tusingwire is from Uganda and has an LL.M. in Law from USF. Her project, "International Transactions and Comparative Law," will provide her with the skills to formulate and implement legal policies to economically empower women in her home country.

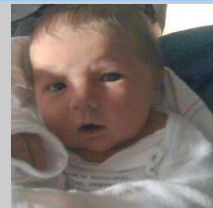

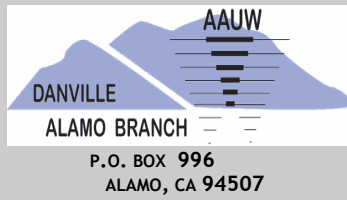
