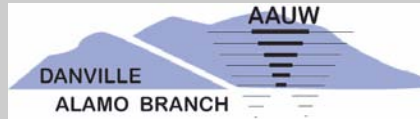

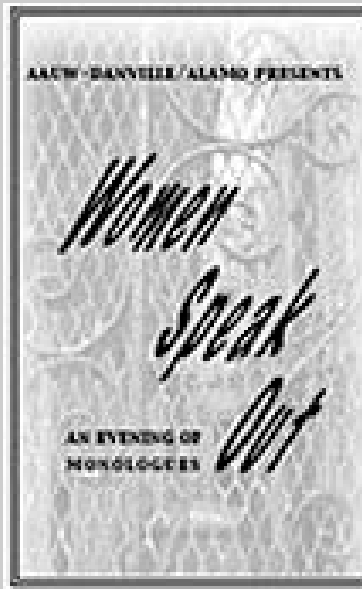

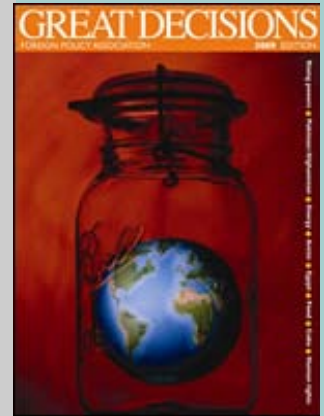

### PUBLIC POLICY

AAUW proudly announces that Lilly Ledbetter will speak at its 2009 National Convention in St. Louis, MO. AAUW's convention, Breaking through Barriers, runs June 26-28, 2009. Having Lilly Ledbetter speak at its convention is a proud moment for an organization which has long championed our right to a fair pay act in her honor. President Obama made The Lilly Ledbetter Fair Pay Act his first order of business as he signed it into law.

Elena Kagan, dean of Harvard Law School, accepted President Obama's nomination to the office of Solicitor General to represent the administration's political views by making legal arguments on cases related to the federal government before the Supreme Court. Kagan is the first female nominee to this position, and is expected to be confirmed in the next few weeks.

After eight years of an administration banning federal grants for stem cell research resulting in U.S. scientific talent going to European and Asian institutions, the times have changed. There are reports from US university science departments of adult stem cell research that is promising, though so much more has to develop in getting these cells to change as the embryonic cells do. So far, the embryonic stem cells are still the gold standard.

Senator Barbara Boxer will be chairing a new Senate Foreign Relations Subcommittee on International Operations and Organizations, Human Rights, Democracy, and Global Women's Issues. This is the first ever subcommittee to encompass a specific focus on global women. Senator Boxer introduced the International Women's Freedom Act of 2009 last month. The bill would create a new State Department office to focus on international women's rights. An ambassador at large and a federal commission would lead the new department and inform Congress and President Obama about the status of women's rights abroad.

International Women's Day will be celebrated on March 5. Join AAUW in this important celebration. AAUW supports comprehensive international family planning programs for women around the world, which once again are available with a full range of reproductive health information and services.

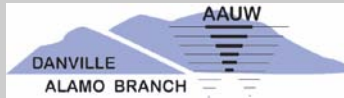

## HIGHLIGHTS OF PROPOSED AAUW BYLAWS

AAUW's strategic planning process began in 2005, with a restructuring approved unanimously at the 2007 AAUW Convention. To complete this restructuring, newly revised bylaws will be presented for approval at the 2009 AAUW Convention at St. Louis.

These bylaws will:

- streamline the current bylaws and move administrative details to policies and procedures;
- provide more flexibility on all levels (branch, state, and national); and
- provide more avenues for all members to participate in the organization, in particular giving every member a vote on national business.

What will NOT change:

- mission-based activities and programming, including the work of the Educational Foundation, Legal Advocacy Fund, and Leadership Training Institute;
- public policy advocacy through the newly named "AAUW Action Fund;" and
- the unique mission and grassroots strength of AAUW.

Summary of Major Changes:

1. **ONE MEMBER-ONE VOTE.** Instead of using a delegate system, every member will have a vote. Members who cannot attend meetings and vote in person will be able to vote by all methods approved by the corporate code of the District of Columbia and the Board (i.e., mail, phone, FAX or electronically).
2. **ONE BOARD.** AAUW and EF boards are merged into one board with authority over all aspects of AAUW activity, including:
  - delivery of the mission through programs and policies;
  - setting membership dues (part of financial administration oversight);
  - appointment of the directors of the AAUW Action Fund, for voter education and related political activities; and
  - appointment and oversight of AAUW committees and task forces, including determining the process for the awarding of fellowships and grants.
3. **MEMBERSHIP OPEN.** Membership is open to any individual supportive of the mission, without regard to college degree status, and to partner members. Partner membership broadens the current college/university membership category to include the possibility of other institutions or organizations that meet the criteria. Open individual membership provides an equal opportunity for all to join, in recognition that one does not need to have educational credentials to work for women's education.
4. **STRUCTURAL FLEXIBILITY.** Branches and states will not be required to make any changes if their current structure works well for them. However, the new bylaws mandate only an administrative and financial contact person from each branch/state, allowing the branches and states to create the structure and leadership positions that make the best use of their resources to fulfill AAUW mission.

THE CITY VISIBLE: *Emily's Bridge*

SHORTLY after graduating from Hunter College in 1978, the photographer Barbara Mensch moved from SoHo to the top floor of a walk-up on Water Street near the South Street Seaport. The charming but decrepit 19th-century brick building was shared by several artists, who sought the low rents and the seaport's industrial grittiness. Ms. Mensch and her neighbors now own the building, which they have renovated.

From windows facing west and from the roof of her loft, Ms. Mensch has views of the Brooklyn Bridge's span, the Manhattan entrance ramp and the Municipal Building. Recently added northern windows have created a special feature: Just outside looms the bridge's massive limestone anchorage, its gargantuan scale dwarfing the viewer within.

Although Ms. Mensch is most widely known for her photographs of the old Fulton Fish Market, to which two books have been devoted, she has also photographed the Brooklyn Bridge for nearly 30 years. As Mont Sainte-Victoire was for Cezanne, the bridge has been a constant in her life and her art. Capturing the bridge at all times of the day and the seasons of the year, she has learned as much about the river and the weather as about the bridge's structure.

Recently, Ms. Mensch has become fascinated with the bridge's history, especially the story of Emily Roebling, right, the remarkable wife of the bridge's engineer, Washington Roebling. When her husband fell ill with "the bends," Emily masked the extent of his illness, acting as his surrogate for 14 years.

In his 1972 work "The Great Bridge: The Epic Story of the Building of the Brooklyn Bridge," the historian [David McCullough](#) writes: "By and by it was common gossip that hers was the real mind behind the great work and that this the most monumental engineering triumph of the age was actually the doing of a woman, which as a general proposition was taken in some quarters to be both preposterous and calamitous. In truth, she had by then a thorough grasp of the engineering involved."

Despite opposition, she won over her critics, and at the 1883 opening, Emily Roebling took the first ceremonial ride across the bridge with President Chester Arthur.

Ms. Mensch has begun to assemble her Brooklyn Bridge photographs into a book called "Emily's Bridge." The photographs shown here, all taken during the past 16 years, express her intimate knowledge of the span as well as her unabashedly romantic view of it. Often shrouded in mist, Ms. Mensch's bridge appears like an apparition from Emily's bygone era.
