DANVILLE BEGINS WORK ON A NEW GENERAL PLAN

New plan should serve blueprint for growth through 2025



It will take more than a year to rewrite the Town's general plan and they are looking for public input, Danville Town officials said Tuesday at the joint meeting of the town council and planning commission. "We want to encourage public participation at each step along the way," Town Manager Joseph Calabrigo said.

Starting May 4, Danville officials will begin the long process, which will start with a review of the current plan, and a look at what areas need to be addressed. Then, beginning in June, the town will get down to the real work on its rewrite of the plan to meet the California Environmental Quality Act. That means hiring a consultant to work on Danville's environmental impact report and addressing state housing and community development requirements, greenhouse gas reductions and considering expanding its "sphere of influence" on the east side.

Mayor Mike Doyle said it's too soon to say what issues will need to be considered, adding that officials haven't even had time to read the 442-page general plan update document. By late May or early June, Town officials will begin the process of rewriting the general plan, which is expected to serve as a blueprint **for** growth until 2025.Officials expect the update to be complete by June 2011, finalizing land use and zoning changes, Town policies and a new environmental impact report. The current plan was written in 1999. •

TECH TREK

Ten Girls to Attend the 2010 Camp

Based on a highly successful Holiday Home Tour last December, our Danville-Alamo branch will send four seventh-grade girls to California State University, Fresno and six girls to Sonoma State University from June 20 to June 26 to participate in an intensive hands-on experience of math, science, technology and related fields. Math/Science teachers at four San Ramon Valley Middle Schools nominated these girls. Twenty-five applicants submitted a required essay and were interviewed. With careful consideration by the Tech/Trek coordinators, Helga Glasson and Bev Nidick, the following ten girls were chosen to attend the summer camp:

McKenna Sherve and Soundarya Jayaraman from Charlotte Wood Rianna Last, Jarnelle Doolittle and Hannah Wendlandt from Los Cerros Megan Chan and Melina Gross from Diablo Vista Gwen Gettle, Kendall Montgomery and Taylor Cuenin from Stone Valley

The Tech/Trek Science Camp for Girls began on the Stanford University campus in 1998 with initial funding from the AAUW Educational Foundation. Additional camps opened on other California campuses in subsequent years. There are now seven participating campuses including Stanford University, UC-Irvine, UC-San Diego, UC-Santa Barbara, Whittier College as well as Sonoma State University and CSU Fresno. The girls will live on the university campus, attend a number of rotating labs and interact with highly qualified teachers and women currently engaged professionally in math, science or technology fields.

In a recent AAUW study entitled, "The Impact of the AAUW California Tech Trek Science Camp for Girls," students who attended the camp during its first four years, 1998-2001, were surveyed. Forty-eight percent of survey respondents agreed that the camp was the most influential personal experience they had in middle school, while fifty-four percent cited it as the most influential academic experience as well. Tech Trek students took a much larger percentage of high–level math and science classes, such as chemistry, biology, physics, trigonometry and calculus in high school than did the national average. (e.g., 57% of Tech Trek students took calculus compared with a 13% national average for both males and females.)

Our Danville/Alamo branch has sent 46 girls to the Tech Trek summer camp since 1999. All of these girls were recently sent invitations to the Tech Trek reunion on Sunday, May 2, at the State AAUW Convention at the San Ramon Marriott Hotel.

Berea College, which addresses sex discrimination in pay equity, is on appeal after the Kentucky Supreme Count ruled in favor of Schuster. To date, LAF has provided over \$235,300 to support these cases.

BETH BATCHELOR

An Artist's Life

I met Beth Batchelor through my daughter Dori who encouraged me to show her a photo of one of my paintings. I was more in awe of her than any teacher I've met as she has the best eye for detail on how to improve a painting. I also found her to be a positive person who is not one to sit in a rocking chair and let life pass her by. Besides, she wouldn't have time to because she has so many projects in the fire at once and still hopes to finish an art book she's started. Beth is also my kind of fun-loving lady. Can you imagine, she had an Elvis Presley impersonator sing for her 92nd birthday last summer and showed me the photographs? Before my interview, she had some 50's music on, and we danced together shaking it up a bit.



Beth's parents were educated Russian immigrants who left Odessa, Ukraine, during the Bolshevik Revolution when their home was pillaged and their belongings taken. Beth was born in Brooklyn, New York, and was on her own at an early age when her mother was hospitalized, and her sister who was six years older took care of her. When she was sixteen, her father died from an accident at work and her mother died shortly afterwards. She lived with her sister until her sister married and moved to Florida.

Beth's art career started at age fourteen when her textile design won at the Brooklyn Museum of Art. She took a four-year art course at the Girls Commercial High School, graduating at sixteen. While in school, the teacher showed her student's work to ad agencies, and only Beth was selected to work for the clients. She also attended Cooper Union Art School on a scholarship. Working as a free lance commercial artist she said,

"I saw two ads for art director in the New York Times, with the exact same words and phone numbers, one for men and one for women, but the woman's salary was half of what they offered the men. You know that the women had to be twice as good to be hired. I opened my own art studio on 5th Avenue in New York as a commercial artist and worked there for fifteen years. I was commissioned by TWA, Minute Maid, Pepsi Cola, and the National Automobile Assn." She also illustrated magazine covers and books. Beth was a beauty, and she also enjoyed acting and studied drama with Susan Hayward.

In 1954, she met Steve Bachelor, a third mate for a merchant ship, at a New Year's Eve party. They came to San Francisco where he lived with his parents. They drove in a Cadillac convertible she bought because she saw movies of blondes in sunny California in convertibles. The weather was cold here, but she never put the top down. She free-lanced and lived in the YWCA until they married in 1960.

"In 1970, we bought a home in Alamo with a lanai, which we turned into an art studio. All that was here between the freeway and our home were orchards and sheep." With Steve now a sea captain gone for three months at a time traveling all over the world, Beth kept busy teaching art classes in Danville and Concord. The students wondered what to do with their paintings. She said, "We could start an artist society and have art shows." In 1977, Beth Batchelor was the founder with Ida Farese as co-founder of the Alamo/Danville Artists Society, a non-profit organization to foster fine art appreciation and education. She was president of the organization for two years, which started with a few members and now has 220 members. When the Artists Society has art shows to sell their paintings, they give a percentage to art programs at 26 local middle and elementary schools. Beth is most proud that they've given about \$100,000 to the schools. They now have a studio in the Blackhawk Plaza. There is also a mural at Neil Armstrong Elementary in San Ramon that Beth inspired and helped work on with the children, which I plan to see.

Beth loves animals and sketches them for clients at pet



exotic animals because his home in Concord was rezoned, she formed the Contra Costa Zoological Society in 1979 and raised money to found a zoo in our area. She appeared at 17 city council meetings and got their approval to bring a zoo to Contra Costa. Mr. Thomas Seeno donated 25 acres in Clayton. The Clayton council had approved the idea, but when the mayor found out where it was to be, she had the council rescind their approval.

In 2001, Beth founded and became the first president of the Contra Costa Academy of Fine Art, because an art institute was needed here. She, as well as other teachers, taught art classes at Richard's Crafts and at her lanai studio. In May, she is teaching two classes at Richard's Crafts in Alamo as well as taking on private commissions doing animal and portrait oils or pastels. Beth is an award-winning artist and has many news clippings about her achievements. She enjoys being with people-that's why she continues working with no plans to retire.


